COUNCIL VACANCY

HGVS THROUGH NEW LONGTON

Recent safety concerns with regard to HGVs going through New Longton, instead of using the new bypass, have been high on the agenda of the Parish Council with many residents attending a virtual Council meeting in July. Discussions with LCC (Highway Authority) and the involvement of our local MP led to a consultation amongst all NL residents who voiced many concerns. The results of the consultation is that new signage will be introduced on the appropriate roads directing HGVs away from the village and onto the new by pass. This strategy is the first stage of trying to remove these vehicles from our village. After a period of time, to give the signage an opportunity to work, a traffic count will be undertaken in order to gauge its success. Should the strategy not work then further measures will be considered.

FLOODING

As we approach winter the likelihood of heavy rainfall and flooding in the area will once again be of concern to residents. We have put together a short synopsis of where to report the various types of flooding that can be experienced. What is very important is that incidents are 'reported' in order that a database of 'events' can be compiled so that the appropriate authorities have records of what has happened, can take action as appropriate and can consider the effectiveness of their action dependant on whether there is further repetition in the future.

LOCAL COUNCIL RESPONSIBILITIES

PARISH COUNCILS were established in law in 1894 having their origins in the development of villages all over England during both Saxon and Norman times. Villages in those past days were ruled by the Lord of the Manor with little national control. Sometimes the villages all met to make decisions which affected the whole community. Gradually it seems that parish priests and sometimes school masters joined the Lord of the Manor to become an effective ruling clique and it was probably from this that the first Parish Councils were formulated.

After the second world war the profile of local Councils increased significantly, and the National Association of Parish Councils was formed. Since that time there has been much debate concerning the value of these Councils however today with a Central Government view of involving local communities it may be that the involvements of Parish and Town Councils will increase in the future.

A Parish Council is democratically elected to serve a defined and local area. Your present Council members were elected to serve for 4 years at the last election in May 2019.

Parish Councils exist to protect the interests of their communities and in many cases provide local services either directly or in support of higher tiers of local government (County, City, Unitary & Borough Councils).

Parish Councils have a statutory right to make comment on all planning applications within their boundaries however the decision does still rest with the higher tier authority for the area.

Longton Parish Council has the services of a Lengthsman who supports and adds value to existing County & Borough authority services. Peter can be seen out and about in Longton and New Longton undertaking general maintenance and litter picking support and he can sometimes undertake Public Right of Way maintenance on paths close to our village centres, for which the Parish Council receive a small grant.

The Council is also able, through representation, to assist in improving the area in general and its opinion is often sought where significant changes to the area are involved such as SRBC planning policies.

Longton Parish Council often comment on planning applications for the area and it is not unusual for residents to seek its support on applications which are of concern to the local populous.

Longton Parish Council is not a clearing house for complaints regarding the service delivery of higher tier authorities which should be addressed in the first place to the responsible authority concerned.

NEW LOCAL PLANNING POLICIES

In November 2019, a consultation was launched which kicked off the start of putting together the next SRBC Local Plan. Despite Covid-19 work has continued on this major planning policy review with 25000 responses to the initial consultation which covers SRBC, Chorley and Preston. The next stage is to consider the many suggestions put forward leading to a further consultation relating to the suggestions that are proposed to be taken forward. The whole process takes several years from start to finish. The current timetable is shown below although this could of course change relative to the Covid-19 pandemic.

- Stage 1 Consultation November 2019 February 2020
- Stage 2 Preferred Options Consultation June 2021 August 2021
- Stage 3 Publication Draft October 2022 December 2022
- Stage 4 Submission to Central Government March 2023
- Stage 5 Adoption December 2023
