Environmental Weight Limit – New Longton

Further to your request for an environmental weight limit in New Longton on behalf of the parish council, I am now able to provide you with an update and possible way forward.

The delivery of an Environmental weight limit in New Longton does not align with the county council's service plan, nor do the volume of HGVs using the route through town exceed any thresholds that we would consider for such a scheme. Surveys in the area show the volume of HGVs to be around 8% of the total traffic. Any scheme that would be considered would therefore be seen as an amenity scheme and therefore fall outside the scope for our funding priorities.

However, the overall situation has moved on since we wrote to you in December 2022. Whilst the county would not consider the scheme on safety grounds, we are willing to allow the parish council the option to fund the introduction of this as an amenity scheme.

The scheme, as requested, by the parish council has an indicative estimate of £90k, however until detailed design work is undertaken, a more precise cost cannot be provided, depending on the sign locations, advance directional signs, Traffic regulation order processes (including possible objections), this estimate could rise or fall.

To provide a detailed scheme estimate, the county would be required to undertake the detailed design process which will cost £15k, if the parish council wish to proceed with the scheme design, this will need to be paid up front.

The county council would then design the scheme and provide a complete cost for the implementation of the environmental weight limit.

The county council cannot guarantee when the designs will be completed as priority work will take precedence, but we would aim to provide a design within six months of design payment.

The parish council need to be aware that payment for the design works and decision to proceed with the completed design (if agreed) does not guarantee that the weight limit will be successful. The weight limit is introduced by a Traffic Regulation Order (TRO), and this includes a public consultation where anybody can object to the proposals, if these objections cannot be mitigated, the TRO could be unsuccessful.

The weight limit will include an "except for access" requirement, as any scheme will not be able to fully prohibit HGVs from the road network, deliveries and businesses that require HGVs within the area will still need legal access. It is therefore important to note that a weight limit will not remove all HGV traffic from New Longton.

Furthermore, it is unlikely that the police will offer enforcement for a completed scheme. Enforcement by the county council using its moving traffic powers will also be unlikely due to the complexities of the restriction and the demand for enforcement on safety critical restrictions being more likely than amenity schemes.

I hope this information allows you to report back to the Parish Council to provide them options to proceed, if they wish.
