The meeting was adjourned

The three residents present all made representation against Planning Application 07/2023/01019/FUL being the erection of five dwellings@ Springfield Farm Drumacre Lane West Longton. They were concerned that the site was in the Green Belt although it was pointed out that the site had been previously developed and was therefore available for the purpose proposed. They were concerned that the additional traffic and vehicular access on a narrow road with no footpaths nor street lighting was dangerous, that the height and orientation of the proposed houses were out of keeping with the area and that the Tara Carr Gutter to which the storm water and treated foul water were proposed to be drained often overflowed and the proposal would exacerbate this problem.

It was resolved that this Council should object to planning application 07/2023/01019/FUL supporting LCC Highways who had already raised concerns regarding traffic and pedestrian safety at the site, that it should also support SRBC Environment Dept in requesting that the proposed drainage systems were appropriate and fit for purpose and that the orientation and height of the proposed dwellings were out of keeping with the area.

Cllr Porter, who has had practical experience of drainage systems, had already provided members with a report which highlighted concerns with regard to future maintenance etc of the proposed system and whilst this was not necessarily a material consideration for the application, the report should be sent to the Planning Dept for their information.

Yew Tree Christmas Lighting.

Dear Mr. MCENNERNEY-WHITTLE,

My name is Martin Reynolds, I was Churchwarden at St. Andrew's Church, Longton from June 2016 until June 2022. Presently I organise the Gardening Group at the church We are a group of retired men who meet twice a month to undertake jobs in and around the church and graveyards endeavouring to keep the areas tidy and looking cared for. The group was formed in 2016. I am also a member of the Parochial Church Council at the church.

In 2018 it was decided that the church would purchase Tree Lights for the Yew Tree that stands in the churchyard in front of the church adjacent to Liverpool Road. To facilitate the lighting, the gardening group dug a trench and fitted trunking for armoured cabling to be installed. The money raised for this venture was raised from Organ Recitals which took place during the Summer months. Every year since 2018, the tree lights have been switched on at the same time as the Longton Light Switch On, in early December each year. (This event is organised by South Ribble Borough Council). The tree lights then remain on until 12th Night. Over the last six years there have been numerous compliments made by both local residents and visitors, in respect of the pleasure they get from seeing the tree illuminated during the Christmas Season.

Unfortunately, due to wear and tear, the lighting will have to be replaced this year. I have made enquiries and the cost of replacement will be in the region of £350.00. To replace like for like, we will require 10 x 10mtre lengths of lighting. The replacement cost will put quite a strain on our church finances. I was wondering if it would be at all possible, if Longton Parish Council could assist us in any way to help us purchase the required replacement lighting.
